Amends the Electronic Products Recycling and Reuse Act. Accelerates by one year (from January 1, 2012 to January 1, 2011) the date upon which certain prohibitions regarding the disposal of electronic products take effect. Makes corresponding changes to the period during which county governments and action agencies may petition the Illinois Pollution Control Board for a temporary waiver from these prohibitions and during which the holders of waivers are exempted from enforcement proceedings. Effective immediately.

Synopsis As Introduced

Creates the Intergovernmental Cooperation Renewable Energy Act. Permits the creation of an agency by intergovernmental agreement for the purpose of investigating the desirability of and necessity for providing waste disposal or electrical energy from renewable sources and to develop means for providing waste disposal or electrical energy from renewable sources. Contains the findings of the General Assembly. Provides that (1) powers specified under the Act are supplemental to existing powers under law and (2) actions taken by specified parties may be done so by resolution. Specifies (1) the status and (2) organization of an agency under the Act. Contains provisions concerning the officers, board composition, and bylaws of an agency. Contains provisions concerning actions of an agency in relation with the Secretary of State. Specifies the powers and duties of an agency. Specifies the manner in which an agency may issue bonds. Specifies which charges an agency may collect for specified activities. Provides that governmental units may contract. Amends the Eminent Domain Act to authorize eminent domain powers under the Act. Contains a severability clause. Effective immediately.

Replaces everything after the enacting clause. Creates the Intergovernmental Cooperation Renewable Energy Act. Contains only a short title provision.

Provides that a taxpayer is entitled to a credit equal to 6 1/2% of the increased income over the prior tax year received by the taxpayer from the provision of green services and the production of green products in this State. Provides that the credit may be carried forward for a period of 5 years.

Synopsis As Introduced

Creates the Prescription Drug Repository Program Act. Requires the Department of Public Health to establish a prescription drug repository program, under which a healthcare facility may donate a prescription drug or supplies needed to administer a prescription drug for use by an individual who meets eligibility criteria specified by the Department. Sets forth requirements that prescription drugs or supplies must meet in order to be accepted and dispensed under the program. Provides that no drugs or supplies donated under the prescription drug repository program may be resold. Provides that nothing in the Act requires that a pharmacy or pharmacist participate in the prescription drug repository program. Provides for civil and criminal immunity for drug and supply manufacturers and pharmacists in relation to the donation, acceptance, or dispensing of prescription drugs or supplies under the prescription drug repository program. Amends the Pharmacy Practice Act, the Wholesale Drug Distribution Licensing Act, the Senior Pharmaceutical Assistance Act, the Illinois Food, Drug and Cosmetic Act, the Illinois Controlled Substances Act, and the Cannabis and Controlled Substances Tort Claims Act to provide that persons engaged in donating or accepting, or packaging, repackaging, or labeling, prescription drugs to the extent permitted or required under the Prescription Drug Repository Program Act are exempt from provisions of those other Acts that might prohibit or otherwise regulate such activity.

Synopsis As Introduced

Amends the Public Utilities Act. Provides that an eligible renewable electrical generating facility includes a generator powered by agricultural residues, wood, landscape trimmings, or organic wastes. Requires a certain percentage of an electricity provider's power to come from biomass. Authorizes increases in the number and nameplate rating of customers who are eligible for net metering. Amends the Environmental Protection Act. Provides that landscape waste is not municipal waste. Extends the length of time that landscape waste may be held at a transfer station before the station must be regulated as a pollution control facility. Exempts lignocellulosic agricultural residues, organic landscape waste, and clean wood waste from regulation as waste. Exempts agricultural waste from certain groundwater rules. Requires the Agency to develop, and the Board to adopt, performance standards for landscape waste gasification facilities as well as testing procedures and standards for the end product produced by those facilities. Defines "flood proofed" for the purpose of a provision concerning local siting review. Makes other changes.

House Committee Amendment No. 1

Removes provisions that (i) specify that an eligible renewable electrical generating facility includes a generator powered by agricultural residues, wood, landscape trimmings, or organic wastes, (ii) require a certain percentage of an electricity provider's power to come from biomass, and (iii) authorize increases in the number and nameplate rating of customers who are eligible for net metering.

Provides that by July 1, 2010, the Department of Public Health shall, after consultation with the Environmental Protection Agency, generate a list of chemicals of high concern. Sets forth the conditions under which the Department, after consultation with the Agency, may designate a chemical of high concern as a priority chemical. Sets forth the applicability of the Act. Authorizes the Director of the Environmental Protection Agency to accept donations, grants, and other funds in order to carry out the purposes of the Act. Provides that the State may cooperate with other states in an interstate chemicals clearinghouse regarding chemicals in consumer products. Effective immediately.

Authorizes the Department of Commerce and Economic Opportunity to award income tax credits based on 25% of the cost of qualifying expenditures for energy efficient projects, such as solar energy equipment, Energy Star certified heat pumps, lighting retrofit projects, and wind equipment. Authorizes the Department to adopt rules. Provides that the credit may be carried forward for up to 5 taxable years. Amends the Illinois Income Tax Act to make conforming changes. Provides that the credit is exempt from the Act's automatic sunset provisions. Effective immediately.

Synopsis As Introduced

Amends the Electronic Products Recycling and Reuse Act. Authorizes each manufacturer that is required to calculate the total weight of televisions sold under its brand to individuals at retail in the State to do so by multiplying the weight of its televisions sold nationally by the quotient that results from dividing the population of Illinois by the population of the United States. Deletes provisions requiring retailers to report the number of televisions sold at retail to individuals in the State. Effective immediately.

House Committee Amendment No. 1

Deletes everything after the enacting clause. Reinserts the provisions of the bill as introduced, with the following changes: (1) changes the definition of "retailer" to include manufacturers of printers, (2) requires printers that exceed certain maximum concentration values for particular hazardous substances to be identified in a statement that must be included in that manufacturer's registration with the Environmental Protection Agency, (3) specifies that manufacturers of printers must pay a registration fee, (4) for the purposes of a report that must be submitted to the Environmental Protection Agency, requires television manufacturers to calculate (rather than estimate) the total weight of televisions sold at retail using one of two specified data sources, (5) makes changes to recycler and refurbisher registration fees, (6) requires each collector's report to the Agency to also include the total weight of printers collected or received for each manufacturer during the program year, (7) authorizes the Department of Central Management Services also to consider the number of printers registered under EPEAT when making certain procurement decisions. Also makes technical changes. Effective immediately.

Creates the Home-Generated Sharps Management Act. Prohibits, beginning September 1, 2011, any person from knowingly placing home-generated sharps waste in certain containers. Provides that, beginning September 1, 2011, home-generated sharps waste must be transported for disposal only in a sharps container, or other containers approved by the Department, and delivered for disposal only at certain locations. Provides that, upon being delivered to those locations, home-generated sharps waste shall be deemed potentially infectious medical waste and may be disposed of by the owners and operators of those facilities as is provided in Title XV of the Environmental Protection Act. Defines "Agency", "construction or demolition debris", "Department", "home-generated sharps consolidation point", "home-generated sharps waste", "household hazardous waste", "household hazardous waste collection facility", "landscape waste", "roll-off container", "sharps container", and "solid waste". Amends the Environmental Protection Act to make corresponding changes.

Creates the Toxic Chemical Safety Act. Requires the Director of the Illinois Environmental Protection Agency to publish a list of chemicals of high concern. Authorizes the Director to designate chemicals of high concern and other chemicals as priority chemicals. Requires the Director to report certain information about the designation process to the General Assembly. Requires each manufacturer and distributor of children's products that contain designated chemicals to provide certain information to the Director. Authorizes the Director, under certain circumstances, to prohibit, by rule, the sale and distribution of children's products containing a priority chemical. Requires manufacturers and distributors whose products are subject to one of these rules to file a compliance plan. Authorizes manufacturers and distributors to apply for, and the Director to grant, waivers from these rules. Exempts certain classes of chemicals, persons, and containers. Authorizes the Director to participate in an interstate clearinghouse to promote chemical safety. Authorizes the Director to request certificates of compliance from manufacturers and distributors. Requires the Director to develop certain educational materials. Creates the Advisory Council on Toxic Substances to provide expert and scientific advice to the Director. Authorizes the Director to adopt rules necessary to implement these provisions.

Amends the Environmental Protection Act. Requires the Illinois Environmental Protection Agency, without public notice, to provide permit applicants with an opportunity to review and comment on draft permits. Authorizes the Agency, without public notice, to modify draft permits. Requires the Agency, to the maximum extent possible, to issue general (rather than site-specific) air permits. Requires the Agency to expedite NPDES permit renewals if certain requirements are met. Authorizes the Illinois Pollution Control Board to adopt rules providing for the issuance of air permits by rule, if it deems that a class of facilities or equipment does not "make a significant contribution of air contaminants to the atmosphere". Requires the Agency to issue permits to the owners or operators of facilities or equipment meeting the requirements of the rules adopted by the Board. Requires the Agency to create common company identification numbers to be used agency-wide to refer to companies that do business in the State. Requires the Agency to create a permit streamlining unit.
